Ensuring Branded Medication is Dispensed as Written

How to ensure the medication is dispensed as it was prescribed?

When writing a prescription referral, the language required by the respective state should be used to ensure the medicine is dispense as written. Each state has determined specific language necessary. Please refer below for exact language each state requires. A state DAW requirement may help you preserve your choice for branded medication if you decide that is the right option for your patient.

South Carolina	Sign on Dispense as Written line - no additional requirements; Medicaid, handwrite "Medically Necessary"

Tennessee	Prescriber must handwrite "Brand name medically necessary," "dispense as written," "medically necessary," "brand name," "no generic," or any abbreviation of this language or circle preprinted "dispense as written"
Texas	Handwrite "Brand Medically Necessary"
Utah	Handwrite "Dispense as Written"
Vermont	Handwrite "brand necessary," "no substitution," "dispense as written," or "DAW"
Virginia	Handwrite "Brand Medically Necessary"
Washington	Sign on Dispense as Written line - no additional requirements
West Virginia	Handwrite "Brand Medically Necessary"
Wisconsin	Handwrite "Brand Medically Necessary"
Wyoming	Handwrite "Do Not Substitute"
